On December 18, 2008, the Board filed a Order Staying Proceedings in this matter "until such time as the Ninth Circuit has issued its final mandate" in the related case of *Alaska Wilderness League v. Kempthorne*, No. 07-71457. *Id.* at 4. While the final mandate has not yet issued in the *Alaska Wilderness League* case, EPA Region 10 hereby notifies the Board of a new development in that case. On March 6, 2009, the three judge panel in the Ninth Circuit case issued an order vacating and withdrawing their opinion of November 20, 2008, and denying as moot the pending petition for rehearing en banc of that opinion. *See* Order, *Alaska Wilderness League v. Kempthorne*, No. 07-71457 (March 6, 2008), *attached*. The court also indicated that it would issue a new opinion to replace the vacated opinion and that the parties in that case would be allowed to file petitions for hearing en banc of the new opinion once it issued.
