Enclosed is a petition dated February 7, 2007 (received by the Environmental Appeals Board on February 8, 2007) filed by Gregg J. Corbo, and Jeffrey T. Blake, Attorneys, on behalf of Town of North Attleboro Board of Public Works and the North Attleboro Wastewater Treatment Facility, asking the Environmental Appeals Board to review a permit determination issued by the United States Environmental Protection Agency, Region 1 in this case.

To assist the Environmental Appeals Board in deciding whether the matters raised by petitioners should be reviewed, please have your staff prepare a response that addresses the petitioners' contentions and whether petitioners have satisfied the requirements for obtaining review under 40 C.F.R. §124.19(a). Include relevant portions of the administrative record with the response, together with a certified index of the entire administrative record. Please file an original (signed in blue ink) and five copies of these materials no later than March 26, 2007, and send a copy of the response and the certified index to petitioners with a certificate of service showing the date and method of service. <sup>1</sup>

All documents, including the materials due March 26, 2007, must reference the appeal number. **IMPORTANT**: In addition, any envelope or other packaging containing documents sent to the Environmental Appeals Board's mailing address or hand-delivery address, as prescribed below, must bear a complete and accurate return address in the upper left hand corner. The envelope or packaging must also clearly state the case name and appeal number in the lower left hand corner.
