FIFTH JOINT MOTION FOR STAY OF PROCEEDINGS AND EXTENSION OF TIME

The Respondent in this proceeding, the United States Environmental Protection Agency Region III ("EPA"); and Petitioners, the Government of the District of Columbia ("DC Government") including its independent instrumentality the District of Columbia Water and Sewer Authority ("DC WASA"); and Friends of the Earth and Defenders of Wildlife ("FOE/DOW"), collectively, "the Parties," hereby submit this Fifth Joint Motion for Stay of Proceedings and Extension of Time for EPA to file a response to the Petitioners' petitions ("Response") and certified index to the administrative record. Pursuant to Order of the Environmental Appeals Board ("Board") dated November 22, 2006, EPA's consolidated brief in response to the DC and FOE/DOW's Petitions for Review is currently due March 1, 2007.

As indicated in previous filings in this matter, the parties have engaged in numerous settlement discussions, including meetings or teleconferences on June 30, 2006; July 19, 2006; September 12, 2006; October 16, 2006; November 9, 2006; December 11, 2006 and January 26, 2007. However, a number of issues remain unresolved, and the parties agree that approximately forty-five (45) additional days would be helpful to complete this process, which may include a formal mediation.

Accordingly, the parties hereby jointly move for an additional stay of proceedings and extension to EPA's filing obligations until April 16, 2007 to facilitate continued settlement discussions.
