JOINT STATUS REPORT

On June 15, 2018, Region 1 of the United States Environmental Protection Agency ("Region 1") and the Massachusetts Department of Environmental Protection ("MassDEP") jointly issued National Pollutant Discharge Elimination System Permit No. MA0028941 ("NPDES Permit") to Keolis Commuter Services, LLC ("Keolis"), Massachusetts Bay Transportation Authority, and Delaware North Corporation, as copermittees. On July 18, 2018, Keolis filed a Petition for Review ("Petition") with the Environmental Appeals Board ("Board" or "EAB") requesting review of one (1) condition of the NPDES Permit. On August 13, 2018, the parties filed a joint motion requesting a 90-day stay to provide time to explore settlement. The Board issued an order granting the motion on August 15, 2018, which stayed this matter until Tuesday, November 13, 2018. The Board's order required the parties to file status reports on Tuesday, September 11, 2018; Tuesday, October 16, 2018; and Tuesday, November 6, 2018. In each status report, the Board required the parties to inform the Board of the progress the parties have made to date. The parties hereby notify the Board that they have agreed on revisions to Section I.B.9 of the Final Permit that will resolve the appeal. On October 15, 2018, the Region notified the Board and the three co-permittees of the Region's determination to withdraw Section I.B.9 of the Final Permit and commence a new draft permit proceeding to address the portion so withdrawn, pursuant to 40 C.F.R. § 124.19(j). *See Notice of Partial Withdrawal Pursuant to 40 CFR Section 124.19(j)* (filed on October 15, 2018). No later than on October 19, 2018, the Region intends to file a motion to dismiss the Petition for Review as moot in light of the withdrawal of Section I.B.9, to which motion Keolis has assented (hereinafter, the "Motion to Dismiss"). Under the negotiated agreement, once the appeal is dismissed, the Region will propose for notice and comment the negotiated revisions to Section I.B.9 of the Final Permit.

<u>CONCLUSION</u>

For these reasons, the parties report that they have reached agreement and respectfully submit that the additional status report due November 6, 2018, should not be necessary. Once the Motion to Dismiss is filed, the parties will await the Board's ruling.
