MOTION FOR EXTENSIONS OF TIME

The United States Environmental Protection Agency Region 5 (“Movant”) requests that the Environmental Appeals Board (“EAB”) grant extensions of time to the schedule outlined in the EAB’s October 17, 2019 “Order Returning Matter to the Regular Docket, Lifting Stay, and Establishing a Briefing Schedule” in the above-captioned matter. Movant seeks this additional time because counsel for Movant will be taking a long-planned 3-week international vacation from October 30 to November 17, 2019. Movant’s counsel believes that the following extensions will allow Movant to provide an adequate response to and will not prejudice Petitioner American Bottom Conservancy (“ABC”) or Intervenor Veolia ES Technical Solutions L.L.C. (“Veolia”):

- Extension from 11/18/19 to 12/9/19: Responses from Region 5 & Veolia due AND Region 5 must file a certified index of the entire administrative record for the Veolia permit no later than 12/9/19; and
- Extension from 12/3/19 to 12/24/19: ABC may file a reply to any responses by this date.

Movant represents that counsel for Petitioner ABC and counsel for Intervenor Veolia do

not oppose the motion. Movant also represents that Region 5 has coordinated with the appropriate offices within EPA Headquarters and they also do not oppose this Motion. For the reasons set forth above, Movant respectfully requests that its Motion for Extensions of Time to respond be granted and that the EAB extend the deadline as outlined above.
