Enclosed is a petition dated November 3, 2006 (received by the Environmental Appeals Board on November 3, 2006) filed by Jeffrey T. Blake and Gregg J. Corbo, Attorneys, Kopelman and Paige, P.C. on behalf of the City of Leominster and the Leominster Water Pollution Control Facility, asking the Environmental Appeals Board to review a permit determination issued by the United States Environmental Protection Agency, Region 1 and the Department of Environmental Protection Commonwealth of Massachusetts in this case.

To assist the Environmental Appeals Board in deciding whether the matters raised by petitioner should be reviewed, please have your staff prepare a response that addresses the petitioner's contentions and whether petitioner has satisfied the requirements for obtaining review under 40 C.F.R. §124.19(a). Include relevant portions of the administrative record with the response, together with a certified index of the entire administrative record. Please file an original (signed in blue ink) and five copies of these materials no later than January 3, 2007, and send a copy of the response and the certified index to petitioners with a certificate of service showing the date and method of service. ¹

All documents, including the materials due January 3, 2007, must reference the appeal number. **IMPORTANT**: In addition, any envelope or other packaging containing documents
