SECOND JOINT STATUS REPORT AND MOTION TO CONTINUE THE STAY

I. Background

On September 27, 2017, Region 1 of the United States Environmental Protection Agency ("Region") issued National Pollutant Discharge Elimination System Permit No. MA0100765 ("NPDES Permit") to the Town of Fairhaven, Massachusetts ("Fairhaven"), authorizing discharges of wastewater effluent from the Town's Wastewater Pollution Control Facility to the Acushnet River. Fairhaven filed a Petition for Review ("Petition") with the Environmental Appeals Board ("EAB" or "Board") requesting review of certain conditions of the NPDES Permit. The Board granted the parties' joint motion requesting a stay until January 12, 2018, to allow the parties to pursue settlement discussions and ordered the parties to file this second joint status report by January 8, 2018. *See* Order Granting Joint Motion for Stay of Proceedings (Nov. 13, 2017).

II. Status Report and Motion to Extend the Stay

The parties continue to make progress on a potential settlement since the filing of the first joint status report. The Region reviewed Fairhaven's proposed revisions to the draft Administrative order on Consent ("Draft Order") and, on December 19, 2017, provided the Town with a revised Draft Order for review. In addition, on December 22, 2017, representatives from Fairhaven, the Region, and the Massachusetts Department of Environmental Protection convened by telephone to further discuss the terms of the Draft Order. Attorneys for the Town and the Region also convened by telephone on several additional occasions. As a result of these discussions, the parties have agreed on a significant portion of the details of the Draft Order, although some important provisions remain to be resolved. The parties believe that, with the benefit of more time, they should be able to come to agreement on those provisions and reach a settlement that avoids litigation before the Board. Consequently, the parties respectfully request that the Board continue the stay for an additional 60 days, with a briefing schedule on the merits of the appeal to be set upon the expiration of the stay. During the extended stay, the parties would, similar to the initial period of the stay, update the Board via two status reports describing the progress of negotiations and, in the case of the second report, advising the Board whether it would be appropriate to continue the stay to allow further settlement negotiations, to assign an EAB Settlement Judge pursuant to the Board's ADR program, to dismiss the Petition, or to allow the stay to expire and set a briefing schedule.

III. Conclusion

For these reasons, and to conserve administrative and judicial resources, the parties respectfully request that the Board issue an order that: (1) continues the stay for an

additional 60 days, with two status reports due to the Board at regular intervals; and (2) delays setting a briefing schedule on the merits of the appeal until the stay expires.
