TO CONDUCT SETTLEMENT DISCUSSIONS**

On May 9, 2011, the Environmental Appeals Board granted Complainant's motion requesting an extension of time to file a response and leave to conduct settlement discussions until June 20, 2011. Complainant respectfully requests a second extension of time to file its response until August 1, 2011, in order to continue its settlement discussions with Respondent.

On or about June 13, 2011, the undersigned personally conducted telephonic settlement discussions with Mr. Tarver of AMRECO LLC. In addition, Mr. Bryant Smalley, the U.S. Environmental Protection Agency ("EPA") Region 6 ("Region") Program Officer assigned to the case, has also had several settlement discussions with Mr. Tarver since May 9, 2011. At each such settlement discussion, Mr. Tarver continues to express desire to settle the case, and both parties believe there is a reasonable basis for settling the matters raised in the initial Complaint and in Respondent's hand-written letter.

As such, Complainant respectfully requests that the Environmental Appeals Board stay these proceedings until August 1, 2011 to allow the parties further opportunity to conduct settlement discussions without the need for further litigation.
