STATEMENT TO THE BOARD RESPONDING TO  
QUESTIONS FROM ORAL ARGUMENT**


Penneco Environmental Solutions, LLC (“Penneco”), applicant for the above-described permit, by and through its counsel, respectfully submits the below response to a question directed to counsel by the Environmental Appeals Board during the July 26, 2018 oral argument in this matter.

1. During oral argument, the Board asked counsel for a page citation in the record for the Pennsylvania State University article referenced on page 13 of Penneco’s brief.
2. Counsel’s response referred the Board to a Pennsylvania State University report, which can be found in Penneco’s Exhibit C, starting at Bates numbers PENN-000044 through Penn-000093. This report was submitted as part of Penneco’s September 10, 2016 response to the Notice of Deficiency during the permitting process.
3. The article referenced in footnote 9 on page 13 of Penneco’s brief is an update to the same study, including the results of seismic monitoring extended into 2015. The latter article

itself is not in the record but provides the Board and other Parties with the completed study results.

4. Penneco's response has been delayed pending receipt of the transcript to confirm the Board's precise question.
5. Penneco did not receive the transcript until August 21, 2018.
