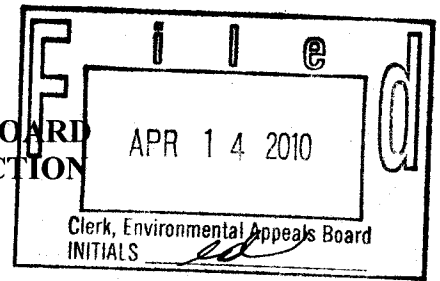

ORDER SCHEDULING ORAL ARGUMENT

In the matter of San Jacinto River Authority, NPDES Appeal No. 09-09, the Board has determined that oral argument may be of assistance in its deliberations. Accordingly, the parties are ordered to participate in oral argument beginning at 10:00 a.m. EDT on Thursday, June 10, 2010, in the Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building, Room 1152, 1201 Constitution Avenue, N.W., Washington, D.C. The Board has allocated sixty (60) minutes total for this oral argument, divided as follows: thirty (30) minutes for San Jacinto River Authority and thirty (30) minutes for U.S. Environmental Protection Agency, Region 6. At the outset of proceedings, San Jacinto River Authority may reserve up to five minutes of its allocated time for rebuttal.

The parties shall notify the Clerk of the Board in writing by Thursday, June 3, 2010, of the names of counsel who will present argument. Counsel for the parties are advised that the Administrative Courtroom is equipped with state-of-the-art video-conferencing equipment and, accordingly, either party may participate in the oral argument by video conference without attending in person. Counsel for either party who wish to participate in this oral argument via

video-conferencing shall contact the Clerk of the Board, at 202-233-0122, no later than Thursday, June 3, 2010, to make arrangements for the use of the video conference equipment.


