#### ORDER RESCHEDULING STATUS CONFERENCE

On October 30, 2015, the Environmental Appeals Board ("Board") granted in part EPA Region 6's motion to stay the proceedings in the above captioned matter until January 27, 2016, to allow for further briefing in a case involving this Site in the United States District Court for the Western District of Oklahoma ("District Court"). The stay order also scheduled a status conference at 3:00 pm EST on January 21, 2016. Subsequently, the parties notified the Board that the Department of Justice's reply in support of its motion to dismiss before the District Court is now due on January 22, 2016. As this filing may be instructive to the Board's efficient and effective handling of this matter, it is prudent to reschedule the status conference until after the reply is filed.

Therefore, the Board is rescheduling the status conference to January 25, 2016, at 4:00 PM EST, to discuss any issues identified in the status report and to address any questions the Board may have. The Clerk of the Board will provide call-in information to the parties prior to the call. This Order does not change the joint status report due date on Friday, January 15, 2016.
