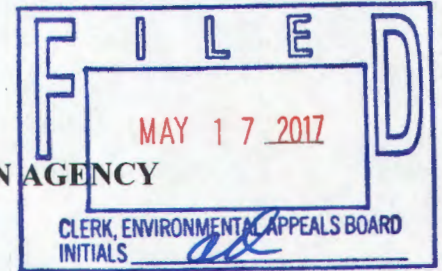

**ORDER SCHEDULING ORAL ARGUMENT AND DIRECTING
PARTIES TO PROVIDE NOTICE OF ELECTION TO PARTICIPATE**

Mr. John L. Anderson (UIC Appeal No. 17-01), the Gila River Indian Community (UIC Appeal No. 17-02), and joint petitioners Southwest Value Partners and the Town of Florence (UIC Appeal No. 17-03), have filed petitions with the Environmental Appeals Board (“Board”) requesting review of certain conditions of a Class III Underground Injection Control permit issued on December 21, 2016, by U.S. Environmental Protection Agency, Region 9. The permit authorizes Florence Copper, Inc. to construct and operate an in-situ copper recovery facility known as the Production Test Facility on FCI property near the town of Florence, Arizona.


The Gila River Indian Community requests the opportunity to present oral argument. Upon consideration, the Board grants the request for oral argument in the Gila River Indian Community petition. The parties to all three petitions may participate in the oral argument. The Board requests that the parties present oral argument on Thursday, July 27, 2017, in the Administrative Courtroom, U.S. Environmental Protection Agency, William Jefferson Clinton East Building, Room 1152, 1201 Constitution Avenue N.W., Washington, D.C. Counsel or other duly authorized representative of the parties may also, upon request, present their arguments by video conference. Oral argument will begin at 1:00 p.m. (Eastern Time).

Participation in the July 27, 2017 oral argument is optional. The Board directs each petitioner and respondent to file a notice with the Board no later than May 31, 2017, stating whether they intend to participate in the oral argument and, if so, who will present oral argument and whether they will attend in person or they request to appear by videoconference.¹ Once the parties have filed their notices of participation, the Board will issue a further order on oral argument designating the order in which the petitions will be heard and allocating time.²


