# STATUS REPORT AND MOTION TO EXTEND STAY

Region 1 ("Region") of the United States Environmental Protection Agency (the Respondent) and the Town of Jaffrey, New Hampshire (the permittee and Petitioner) jointly provide this status report and respectfully request that the Environmental Appeals Board ("Board") extend the stay the proceedings in the above-captioned matter by an additional two months to July 23, 2010, to allow the parties to finalize and implement a settlement.

### BACKGROUND

This is an appeal of NPDES Permit No. NH0100595 ("Permit"), which the Region reissued to Petitioner on September 28, 2009. On December 8, 2009, the Board issued a stay of proceedings for the parties to explore settlement negotiations, and stayed the appeal until March 24, 2010. On March 15, 2010, the Board extended the stay to May 24, 2010, and ordered that a status report be filed no later than May 12, 2010, advising whether the Board should further extend the stay, establish a revised schedule for the litigation, or take other appropriate action.

### STATUS REPORT

The parties have made substantial progress since the Board's most recent order and are close to reaching agreement on all issues. Specifically, the Petitioner and the Region have agreed that the Region will modify the Permit under 40 C.F.R. § 124.5 to revise certain effluent limits. The parties have also made substantial progress towards agreement on an administrative

compliance order that the Region would issue upon the Permit's finalization. While the parties

have not yet reached complete agreement on the terms of such an order, they are confident that

they will be able to do so in the very near future.

REQUESTED RELIEF AND GROUNDS FOR SUCH RELIEF

The parties jointly request that the Board extend the stay of proceedings by two months

from May 24, 2010 to July 23, 2010. During this time, the parties expect to complete

negotiations on an administrative compliance order. The Region also expects to prepare a permit

modification under 40 C.F.R. § 124.5 (including a statement of basis under 40 C.F.R. § 124.7)

and to conduct a 30-day public comment period as required by 40 C.F.R. § 124.10. The parties

proposes to submit a status report by July 15, 2010, advising whether the Board should further

extend the stay, establish a revised schedule for the litigation, or take other appropriate action.

An extension of this length is reasonable and necessary given the need to conduct the

processes described above. If a stay is not granted, the parties will be forced to divert their time

and effort to the proceedings before this Board, when there is a substantial possibility that at least

some of the issues raised in the petition for review may be resolved through settlement

discussions. Accordingly, in an effort to conserve administrative and judicial resources, and to

encourage efficiency and promote judicial economy, the parties request that the Board grant this

motion and stay all proceedings in this matter until July 23, 2010.
