MOTION TO TERMINATE STAY AND TO WITHDRAW PETITION FOR REIMBURSEMENT PURSUANT TO 42 U.S.C. § 9606(b)

The Courts have now denied, or declined to hear, the requests of Hercules Incorporated ("Hercules") for relief on divisibility, administrative law, and constitutional law grounds. *United States v. Vertac Chemical Corp.*, 364 F.Supp.2d 941 (E.D. Ark. 2005), *aff'd*, 453 F.3d 1031 (8th Cir. 2006), *cert. denied*, ____ U.S. ____ (April 23, 2007) (No. 06-865).

Accordingly, Hercules moves to terminate the stay in this matter and to withdraw its Petition for Reimbursement pursuant to 42 U.S.C. § 9606(b) with prejudice. A proposed Order is attached.
