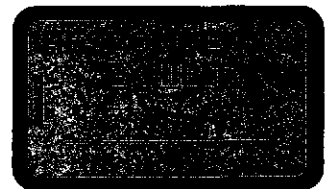

The Prevention of Significant Deterioration permits being issued for the proposed plant grant approval to construct pursuant to the federal rules for Prevention of Significant Deterioration of Air Quality (PSD), 40 CFR 52.21. Accordingly, individuals who filed comments on the draft PSD permits or participated in the public hearing may petition the U.S. Environmental Protection Agency (USEPA) to review the PSD provisions of the issued permits. In addition, as comments were submitted on the draft PSD permits for the proposed facility that requested a change in the draft permits, the issued PSD permits do not become effective until after the period for filing of an appeal has passed. This letter is the service of notice that final permit decisions have been made. The procedures governing appeals are contained in the Code of Federal Regulations (CFR), "Appeal of RCRA, UIC and PSD permits," 40 CFR 124.19. If an appeal request will be submitted to USEPA by a means other than regular mail, refer to the Environmental Appeals Board website at [www.epa.gov/eab/eabfaq.htm#3](http://www.epa.gov/eab/eabfaq.htm#3) for instructions.
