Petitioner wishes to introduce the Draft PM 2.5 study authored by the BAAQMD into the record and explain its significance and how the BAAQMD and Russell City Energy Center have quoted selected portions of the study to misinform the Board about the results of the study.

Petitioner also whishes to respond to BAAQMD assertions that it has evaluated all relevant issues in relation to its BACT determination for PM-10 Emissions from the proposed projects cooling tower.

Petitioner apologizes that he cannot afford an attorney but has made a good faith effort to comply with all of the Boards filing requirements.
