ORDER REGARDING RESPONSE TO REGION'S MOTION TO DISMISS

On December 19, 2018, the U.S. Environmental Protection Agency ("EPA" or "Agency") Region 9 ("Region") filed a notice of permit withdrawal and a motion to dismiss as moot the Petition for Review filed by Dine' Citizens Against Ruining the Environment, San Juan Citizens Alliance, Amigos Bravos, Center for Biological Diversity, and Sierra Club (collectively, "Petitioners"). *See* Notice of Withdrawal Pursuant to 40 C.F.R. § 124.19(j) (Dec. 19, 2018); Region IX's Motion to Dismiss (Dec. 19, 2018) ("Motion"). The Region stated that the permittee, Arizona Public Service Company ("APS"), does not oppose the Region's motion to dismiss, and that the Petitioners express no position at this time. Motion at 3.

Pursuant to 40 C.F.R. § 124.19(f)(3), any party that chooses to file a response to a motion must do so within fifteen days after service of the motion. In this instance, Petitioners and APS would have needed to file a response, if any, to the Region's motion no later than January 3, 2019. In consideration of the recent government shutdown, any party that chooses to file a
