The Initial Decision Upon Remand was issued in this matter on September 12, 2009. Following two extensions of the briefing schedule, Respondents filed their Appeal Brief on March 27, 2009. On April 13, 2009, the Parties jointly informed the Board that they had reached an agreement in principle. On April 14, 2009, the Board granted a Stay of this matter and extended the time for reducing the agreement to writing or the filing of Complainants' Response brief to June 30, 2009.

The Parties have exchanged drafts of two written instruments that will together comprise the settlement of this matter. Due to scheduling conflicts, Complainants believe it will take approximately three additional weeks to finalize and obtain the necessary signatures on these instruments.
