#### JOINT MOTIONS FOR STAY OF PROCEEDINGS AND EXTENSION OF TIME

The Respondent in this proceeding, the United States Environmental Protection Agency Region III ("EPA"); and Petitioners, the Government of District of Columbia ("DC Government"); the District of Columbia Water and Sewer Authority ("DC WASA"); and Friends of the Earth and Defenders of Wildlife ("FOE/DOW"), collectively, "the Parties," hereby submit this Joint Motion for Stay of Proceedings and Extension of Time for EPA to file a response to the Petitioners' petitions ("Response") and certified index to the administrative record. Pursuant to Order of the Environmental Appeals Board ("Board") dated May 25, 2006, EPA's consolidated brief in response to the DC and FOE/DOW's Petitions for Review is currently due August 4, 2006. The Board granted the previous extension to facilitate settlement discussions among the parties.

Settlement discussions between the parties occurred on June 30, 2006 in Washington, D.C., and are expected to continue on July 19, 2006. Because the parties anticipate that continued settlement discussions will be necessary at least 60 days past August 4, 2006, they hereby jointly move for an additional stay of proceedings and extension to EPA's filing obligations until October 3, 2006 to facilitate continued settlement discussions.
