JOINT STATUS REPORT

Pursuant to the March 28, 2019 Order Granting Stay (the “Stay Order”), the Three Affiliated Tribes of North Dakota (the “Tribe”), Goodnight Midstream Bakken, LLC (“Goodnight”), and the Environmental Protection Agency Region 8 (the “EPA”)(collectively the “Parties”) submit the following Joint Status Report.

Goodnight and the Tribe have reached an agreement regarding the Red Murphy well. The parties are in the process of finalizing the agreement and implementing its provisions. Upon final execution of the agreement Goodnight will seek to expire the Red Murphy well permit. Subsequently the Tribe will move to dismiss this matter as moot.

The Parties agree that finalizing the agreement and seeking to expire the well will require additional time. Therefore, pursuant to the Stay Order the parties request this matter be stayed an additional sixty (60) days. If the Parties are able to execute the agreement and expire the permit before the conclusion of sixty (60) days, the Tribe will file the aforementioned dismissal motion. The Parties see no obstacle to completion of this matter and do not expect that another extension will be required.
