On December 11, 2020, EPA Region 1 ("EPA") filed the Certified Index to the Administrative Record ("Certified Index") of NPDES Permit No. MA0101613, issued to the Springfield Water and Sewer Commission. On March 5, 2021, the Environmental Appeals Board ("Board") issued an Order Requiring Documents to be Included in the Administrative Record ("Order"). The Board's Order identified two specific documents to be included in the Administrative Record: Office of Water, U.S. EPA, No. 832-B-95-002, Combined Sewer Overflows – Guidance for Long-Term Control Plan G-1 (1995) and the Combined Sewer Overflow (CSO) Control Policy, 59 Fed. Reg. 18,688 (Apr. 19, 1994), citing to 40 C.F.R. § 124.17(b).

Under 40 C.F.R. § 124.17(b), "For EPA-issued permits, any documents cited in the response to comments shall be included in the administrative record for the final permit decision as defined in § 124.18." EPA has reviewed the Response to Comments and has identified the following documents, including the two documents identified by the Board, that EPA expressly cited in responding to comments, but that were not individually listed in the relevant section of the Certified Index of the Administrative Record:

Material readily available at the issuing Regional Office, or published materials which are generally available and which are included in the administrative record under the standards of this section or of § 124.17 ("Response to comments"), need not be physically included in the same file as the rest of the record as long as it is specifically referred to in the statement of basis or fact sheet or in the response to comments.

The Region has in the past construed 40 C.F.R. § 124.18(e) to not require EPA to individually catalogue each generally available document expressly cited by EPA in responding to comments, because these documents are by definition part of the administrative record. See 40 C.F.R. § 124.17(b). In most cases, the Region's response to comments includes hyperlinks to these documents. EPA observes that there has been no dispute in this case over what constitutes the administrative record. EPA will conform its administrative record practice to be fully consistent with the Board's Order going forward, i.e., EPA will individually catalogue in the administrative record each document cited in responses to comments, even if "generally available."
