**DECLARATION OF RICHARD C. RATLIFF**

I, Richard C. Ratliff, hereby declare as follows.

1. I am employed by the California Energy Commission (“Energy Commission”) as Senior Staff Counsel. I worked on the Russell City Energy Center amendment licensing proceeding, Docket No. 01-AFC-7C (“Proceeding”). I have personal knowledge of the matters stated herein and know them to be true, and I can testify truthfully and competently thereto.

2. Attached hereto as Exhibits A through C, respectively, are true and correct copies of mailing lists used by Energy Commission staff to undertake public outreach regarding the Proceeding. Exhibit A is the “Interested Agency” list, which includes approximately 30 regional, state and federal agencies. Exhibit B is the “Property Owner” list, which includes approximately 130 individuals and business that own property adjacent to or near the site of proposed Russell City Energy Center project. Exhibit C is the “General List”, which includes approximately 140 other people, businesses, and other entities to whom the Energy Commission sent information.

3. The “General List” has been redacted to remove specific identifying information for private individuals such as names and street address numbers. I have reviewed the un-redacted lists, and none of them contains the name “Rob Simpson”.

4. Jewel Hargleroad, Esq., appeared in the Proceeding as an attorney representing several parties, but not until after the Commission adopted its Final Decision. When she did appear, she did not purport to represent Rob Simpson.
