

NOTICE OF WITHDRAWAL OF PETITION FOR REVIEW

Petitioners PPG Industries Ohio, Inc. and PPG Industries, Inc. hereby provide notice to the Environmental Appeal Board of their voluntary withdrawal Petition for Review of Permit No. RCRA OHD 004 304 689 in this proceeding. As previously reported to the Board, Petitioners and Region V of the United States Environmental Protection Agency reached a settlement on all issues raised in the Petition for Review filed on May 7, 2007. As reported to the Board in a Joint Status Report filed by the parties on September 26, 2008, the parties initiated, and have since completed, modification of the permit to implement the settlement. By email dated December 4, 2008, Region V confirmed the issuance of the modified permit following the necessary public notice period. As the settlement has been fully implemented through the modification of the permit, Petitioners withdraw as moot the Petition for Review.
