NON-PARTY AMICUS BRIEF

PRO SE Amicus Curiae Marily Woodhouse Submits the following information to assist the Environmental Appeals Board ("Board") in forming a more comprehensive picture of how overall failures in oversight have resulted in degradation of public resources and impacts to community health.

Amicus Curiae Marily Woodhouse asserts:

EPA Region 9 conducted a public meeting on December 10, 2013 to answer questions and distribute information regarding a permit to allow Sierra Pacific Industries to enlarge their biomass facility from a 4 MW plant to a 31 MW plant. An exceptionally cold storm was in the area at the time of the meeting, making road conditions in the mountainous areas hazardous. These dangerous road conditions, coupled with the holiday season, made it impossible for affected residents of the area, including myself as a representative of a NGO, to attend the meeting.

Consequently, we were not given the opportunity to seek answers regarding the apparent nonsensical plan by the EPA to allow new construction and a 675% increase in the plant to be allowed as a modification of an existing permit, rather than requiring a new permit.

I, and many others stakeholders, were denied an opportunity to ask questions about the status of PSD permit No. 94-VP-18b.

Two exhibits are included with this Amicus Brief.

A. The first item is a DVD entitled "Clearcut Nation" which documents the current cumulative effects in the land area that will be used to provide the additional fuel that a larger 31 MW plant would require. This documentary provides details regarding how federal and state laws are implemented on the ground. Submitted as exhibit 1.

B. The second item is one of Sierra Pacific Industries Herbicide Spray Plans for 2010. No evaluation of the significant increase in biomass consumption that would be required to fuel this 31 MW plant would be credible without consideration of the subsequent increased use of Herbicides and their effects on water quality, an issue of vital interest in California. Submitted as exhibit 2.

Amicus Curiae Marily Woodhouse hopes that the Board will consider the matter of PSD permit No. 94-VP-18b (now under appeal) in light of the information presented.
