NOTICE OF WITHDRAWAL OF PETITION FOR REVIEW

Petitioner, Williams Four Corners LLC (Williams), hereby provides notice to the Environmental Appeal Board of the withdrawal of a petition for review filed for the above-captioned matter with request to a Title V (Part 71) renewal permit. On April 1, 2010, the United States Environmental Protection Agency (EPA), Region 6 issued a final Title V permit that incorporated certain changes requested by Petitioner. The revised permit renders Williams' petition for review unnecessary.

Background

- 1. On September 30, 2009, EPA Region 6, issued a renewal Title V Permit, effective October 30, 2009, for the Los Mestenios Compressor Station, a natural gas compressor station located in Rio Arriba County, New Mexico, which is owned and operated by Petitioner.
- 2. Pursuant to 40 C.F.R. § 71.11(l), on October 30, 2009, Williams timely requested that this Board review certain conditions set forth in the permit.
- 3. On November 20, 2009, EPA Region 6 and Williams met to discuss possible resolution of the issues set forth in the petition.

- 4. On December 9, 2009, EPA Region 6 filed a motion to stay Williams' petition for review, stating that the agency planned to develop clarifications in a new draft Title V permit. On December 11, 2009, the Board granted a stay of proceedings until April 15, 2010.
- 5. After further negotiations between the parties, EPA Region 6 proposed a revised Part 71 permit for the Los Mestenios facility. On February 25/26, 2010, public notice of the changes to the Part 71 permit was published for comment. The public comment period ended on March 29, 2010.
- 6. On April 1, 2010, EPA Region 6 issued a final Part 71 permit for the Los Mestenios facility and, pursuant to 40 CFR § 71.11(i)(2)(iii), the permit became effective immediately.

Withdrawal of Petition

7. For the foregoing reasons, Williams hereby withdraws its Petition for Review filed with the the Board and requests that this matter be closed.
