The United States Environmental Protection Agency (EPA) Region III (Region) respectfully requests leave to file a response by August 21, 2014 to Petitioner Wanchisn's Motion to File the Government Accounting Office Document GAO 14-555 (hereinafter "GAO Report") in the above captioned matter. As grounds for the motion, the Region states as follows:


1. On August 4, 2014, Petitioner Wanchisn filed a Motion to File GAO 14-555 (hereinafter "Motion") in the Pennsylvania General Energy Company, LLC (PGE) for an Underground Injection Control (UIC) Class II injection well permit appeal matter.
2. The Region first learned that Petitioner Wanchisn filed the Motion when the Region III attorney reviewed the EAB docket on August 13, 2014.
3. The Region did not receive Petitioner Wanshisn's motion by mail or otherwise prior to August 13, 2014.

4. The GAO Report is over 100 pages in length.

5. The Region will need time to review the GAO Report and consult with its Office of General Counsel regarding the report and any EPA Region III response to Petitioner Wanchisn's Motion.

For the foregoing reasons, the Region requests that this Court grant this motion and allow the Region until August 21, 2014 to file a response to Petitioner Wanchisn's Motion to File GAO Report 14-555.


