

FINAL ORDER

Pursuant to Section 14(a) of FIFRA, 7 U.S.C. 136l(a), it is hereby ORDERED THAT:

- Respondent shall comply with all of the terms of the Consent Agreement, incorporated herein by reference;
- 2. Respondent is assessed a civil penalty in the sum of \$2,500,000 pursuant to the terms of the Consent Agreement;
- 3. Respondent shall, within sixty (60) calendar days of the execution the Final Order, either:
 - (a) Dispatch a cashier's or certified check payable to the order of the "Treasurer of the United States of America" in the amount of \$2,500,000 and bearing the notation, "Monsanto Company Civil Penalty Docket No. FIFRA HQ-2010-5014" to the following address:
