By letter dated December 14, 2000, Air Products of Puerto Rico, Inc. ("Air Products"), the petitioner in the above-referenced matter, moves to withdraw the above-referenced petition filed with the Environmental Appeals Board under 40 C.F.R. Part 124. In support to its request, Air Products explains that its individual National Pollutant Discharge Elimination System ("NPDES") permit was transferred to a Multi-Sector General Permit ("MSGP") and coverage under the MSGP began on November 15, 2000. In addition, U.S. EPA Region II is "inactivating" the individual permit subject of this appeal and relieving Air Products of its responsibilities under the permit. Accordingly, Air Products' petition for review is now moot.

In light of the above, Air Products' request to withdraw NPDES Appeal No. 00-12 is hereby granted, and the Board hereby dismisses with prejudice the appeal in its entirety.
