ORDER EXTENDING TIME TO FILE RESPONSES TO PETITIONS

By motion dated June 25, 2007, United States Environmental Protection Agency, Region 3 (the "Region"), requests an extension of time to file its response to the petitions for review filed by the Chesapeake Bay Foundation, the District of Columbia Water and Sewer Authority ("WASA"), and Friends of the Earth and the Sierra Club ("FOE/SC") (collectively, "Petitioners"), in the above-captioned appeals. These petitions relate to certain provisions in the April 5, 2007 modification of National Pollutant Discharge Elimination System ("NPDES") Permit Number DC021199. The Board required the Region to file a response to the petitions by June 28, 2007. The Region requests an extension of time to file its response until July 6, 2007. In its motion, the Region states that Petitioners consent to its request for an extension of time.

Also on June 25, 2007, WASA filed a motion requesting an extension of time to file its response to the petition for review filed by FOE/SC in NPDES Appeal Number 07-12, to the extent that the Board grants the Region's motion for extension described above. The Board previously had granted WASA's motion to intervene in that appeal and required WASA to respond to FOE/SC's petition for review by June 28, 2007. Like the Region, WASA requests

an extension of time to file its response until July 6, 2007, and states that FOE/SC consent to the request for extension.

For good cause shown, the Board hereby grants both motions for extension. The Region and WASA shall file their responses to the respective petitions for review no later than July 6, 2007.
