ORDER GRANTING MOTION TO EXTEND PAGE LIMIT

By order dated May 12, 2016, the Environmental Appeals Board ("Board") exercised its authority to review this matter *sua sponte* pursuant to 40 C.F.R. sections 22.27(c)(4) and .30(b), and ordered U.S. EPA's Air Enforcement Division, Office of Civil Enforcement, Office of Enforcement and Compliance Assurance ("Air Enforcement Division") to file a brief on or before June 16, 2016, addressing penalty assessment and service issues. *See* Order Electing to Exercise Sua Sponte Review and Establishing Briefing Schedule. The Board limited the brief to 20 double-spaced pages (excluding exhibits and supporting documentation).

On June 10, 2016, the Air Enforcement Division filed a motion seeking a 15-page extension of the page limit. Motion for Extension of Page Limit ("Motion"). In support of the Motion, the Air Enforcement Division states that the additional pages are needed to "thoroughly give a count-by-count description of the penalty policy calculation as requested in the [Board's] May12, 2016 Order * * * as well as to adequately provide the [Board] with enough detail on the issue of service." Motion at 1.

For good cause shown, the Motion is granted. The page limit for the Air Enforcement Division's brief is extended to 35 double-spaced pages. Similarly, the page limit for Respondents' response brief is extended to 35 double-spaced pages, and the page limit for the Air Enforcement Division's reply is extended to 15 double-spaced pages.
