ORDER GRANTING UNOPPOSED MOTION
FOR EXTENSION OF TIME TO FILE REPLY

The Oglala Sioux Tribe, Black Hills Clean Water Alliance, and NDN Collective (“Petitioners”) filed a petition for review on April 11, 2025, to which U.S. EPA Region 8 and permittee Powertech (USA) Inc. filed timely responses. On May 14, 2025, Petitioners filed an unopposed motion requesting an extension of time to June 12, 2025, to reply to the responses to the petition for review. Unopposed Motion for Extension of Time to File Reply 1 (May 14, 2025).

Based on the representations in the motion, the Board hereby **GRANTS** the motion. *See* 40 C.F.R. § 124.19(n). Accordingly, the reply must be filed and served on or before **Thursday, June 12, 2025**. The reply “may not raise new issues or arguments” and should respond only to the arguments in the Region’s and Powertech’s response briefs. *Id.* § 124.19(c)(2).
