

ORDER GRANTING UNOPPOSED MOTION TO STAY PENALTY PENDING APPEAL


By motion dated June 25, 2007, Howmet Corporation ("Howmet") seeks a stay of the \$309,091 penalty ("Penalty") assessed by the Board in its May 24, 2007 final order in the above-captioned matter, pending Howmet's appeal of the Board's order. Howmet states that counsel for United States Environmental Protection Agency ("EPA") Regions 2 and 6 have indicated that EPA does not oppose the motion and agrees to stay payment and collection of the penalty pending Howmet's appeal, on the condition that Howmet file its appeal on or before July 24, 2007. See Unopposed Motion to Stay Penalty Pending Appeal ("Motion") at 1.

For good cause shown, the Board hereby grants Howmet's Motion and stays the Penalty pending Howmet's appeal of the Board's order, on the condition that Howmet file such appeal on or before July 24, 2007. Should Howmet fail to appeal the Board's final order on or before July 24, 2007, payment of the Penalty will be due immediately. Should Howmet appeal but fail to prevail on the appeal, the Penalty will be due within 30 days of the decision by the reviewing

court, unless that court prescribes a different deadline for payment or the parties agree otherwise.
