ORDER GRANTING EXTENSION OF TIME TO FILE PETITION FOR REVIEW

On April 13, 2015, Phoenix Production Company ("Phoenix") filed a motion for a thirty-day extension of time to file a petition for review of National Pollutant Discharge Elimination System ("NPDES") Permit Nos. WY-0024945 and WY-0024953. Region 8 of the U.S. Environmental Protection Agency issued the permits to Phoenix on March 12, 2015, authorizing discharges of treated wastewater from Phoenix's facilities in Fremont County, Wyoming, into an unnamed ephemeral tributary of Dry (Pasup) Creek and the Wind River.

Phoenix reports that EPA Region 8 does not oppose this extension request.

For good cause shown, the Board hereby **GRANTS** an extension of time to Phoenix to file its petition for review of the two NPDES permits. Phoenix's petition must be filed with the Clerk of the Environmental Appeals Board on or before **Monday**, **May 18, 2015**.
