On July 24, 2007, the parties in the above-captioned matter, U.S. EPA Règion 5 (the "Region") and PPG Industries Ohio, Inc. and PPG Industries, Inc. (collectively "PPG"), filed a joint motion requesting to stay the proceedings in this case until September 7, 2007.¹ The parties represent that they believe that they may be able to settle some or all of the issues raised in PPG's petition. Therefore, the parties request that their joint motion be granted to allow the parties to conduct settlement discussions without the need for further litigation.

For good cause shown, the Board hereby grants the parties' request to stay the proceedings until Friday, September 7, 2007.

¹ On May 7, 2007, PPG filed a petition for review in the above-captioned matter challenging a permit decision issued by Region 5 regulating certain hazardous waste operations at PPG's Circleville, Ohio facility.

On or before September 7, 2007, the parties shall submit a report regarding the status of the settlement negotiations which shall include a discussion of whether it is appropriate to continue the stay or dismiss the petition.²
