

**ORDER RESCHEDULING ORAL ARGUMENT**

By order dated August 15, 2007, the Environmental Appeals Board ("Board") scheduled oral argument in the above-captioned matter for Tuesday, October 30, 2007, at 10:00 a.m. EDT in EPA's Administrative Courtroom. Due to a scheduling conflict, oral argument is hereby rescheduled to begin at 10:00 a.m. EST on Monday, November 5, 2007, in the Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building, Room 1152, 1201 Constitution Avenue, N.W., Washington, D.C. As noted in our August 15 order, the Board has allocated sixty (60) minutes total for this oral argument, divided as follows: (1) thirty (30) minutes for Martex Farms, S.E., and (2) thirty (30) minutes for U.S. EPA's Special Litigation and Projects Division.

The parties shall notify the Clerk of the Board in writing by October 25, 2007, of the name of counsel who will present argument. Counsel for the parties are advised that the Administrative Courtroom is equipped with state-of-the-art video-conferencing equipment and, accordingly, either party may participate in the oral argument by video conference without attending in person. Counsel for either of the parties who wish to

participate in this oral argument via video-conferencing shall contact the Clerk of the Board, at 202-233-0122, no later than Tuesday, October 16, 2007, to make arrangements for the use of the video conference equipment.


