**ORDER GRANTING PETITIONERS' EXPEDITED MOTION  
FOR LEAVE TO EXCEED WORD LIMITATION**

The Center for Food Safety, Recirculating Farms Coalition, Tampa Bay Waterkeeper, Suncoast Waterkeeper, Healthy Gulf, and Food & Water Watch (collectively "Petitioners") filed an expedited motion with the Environmental Appeals Board ("Board") seeking leave to file a petition for review exceeding the 14,000-word limit set forth in 40 C.F.R. § 124.19(d)(3). Petitioners' Expedited Motion for Leave to Exceed Word Limitation, at 2 (June 12, 2025) ("Motion"). Petitioners request leave to file a petition not exceeding 16,500 words and represent that the U.S. Environmental Protection Agency is not opposed to the requested relief. *Id.* at 3.

Based upon Petitioners' representations in the Motion and in accordance with 40 C.F.R. § 124.19(d)(3), the Board hereby **GRANTS** the Motion. Petitioners shall file a joint petition for review, not exceeding **16,500 words**, on or before **Monday, June 16, 2025**.
