ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEF AND ORDER EXTENDING DATE FOR FILING AMICUS BRIEFS

On December 10, 2021, Petitioner City of Keene ("City") filed an unopposed motion seeking an extension of time within which to file its reply brief. City of Keene Unopposed Motion for Extension of Time to File Reply Brief (Dec. 10, 2021) ("Motion").

Regulations that govern the appeal of National Pollutant Discharge Elimination System permits provide that "petitioner may file a reply within 15 days after service of the response."

40 C.F.R. § 124.19(c)(2). Pursuant to the scheduling order issued previously by the Environmental Appeals Board ("Board") in this matter, the response by EPA Region 1 ("Region") is due by December 15, 2021. *See* Order Granting Extension of Time for Filing Brief in Support of Petition for Review 2 (EAB Sept. 27, 2021). Accordingly, if the Region files and serves its response on December 15, 2021, the City's reply would be due fifteen days later—December 30, 2021. The scheduling order also established December 30, 2021, as the deadline for any amicus briefs. *Id*.

The City requests that the deadline for filing its reply brief be moved from December 30,

2021, to January 6, 2022. Motion at 1. In support, the City points out that December 30 is

"during the winter holidays" and states that several "key staff members and legal and technical

professionals" will be unavailable during the week the reply brief is due. *Id.* Thus, the City

asserts that it requires an extension of time in order to allow "sufficient time [to] review EPA's

response in full and provide a clear and comprehensive reply." Id. at 2. The City represents that

its motion is unopposed. Id.

Accordingly, based on the City's representations, the Board **GRANTS** this motion. Any

reply by the City to the Region's response must be filed on or before January 6, 2022. In

addition, in the interest of efficiency, we are also extending the deadline for the filing of any

amicus briefs to January 6, 2022. See 40 C.F.R. § 124.19(n) ("the Environmental Appeals

Board may do all acts and take all measures necessary for the efficient, fair, and impartial

adjudication of issues arising in an appeal").

So ordered.
