ORDER GRANTING EXTENSION OF TIME TO REPLY

On February 22, 2024, Andrew Lenderman, Ben Lenderman, Floyd Lenderman, and Jessie Lenderman filed a petition for review of two Class VI underground injection control permits issued by U.S. Environmental Protection Agency Region 5 to Wabash Carbon Services, LLC. Permittee Wabash Carbon Services, LLC filed a response to the petition on April 22, 2024. In response to two motions filed by the Region, the Board extended the time for the Region to file a response brief, certified index, and relevant portions of the administrative record until May 10, 2024. Order Granting Second Extension of Time 1-2 (Apr. 23, 2024).


The Petitioners now request until May 24, 2024, to file a single reply to the Region’s and Permittee’s response briefs. Unopposed Motion for Extension of Time to Respond 1 (May 2, 2024). Petitioners state they will comply with the word limitation for a single reply. Id. Petitioners indicate that counsel for the Region and the Permittee “have agreed to the requested extension.” Id. at 2.

Based on the representations in the Motion and the circumstances presented, the Board **GRANTS** the Motion. *See* 40 C.F.R. § 124.19(f)(6), (n). Petitioners' single reply to the Region and the Permittee is due on or before **Friday, May 24, 2024**.
