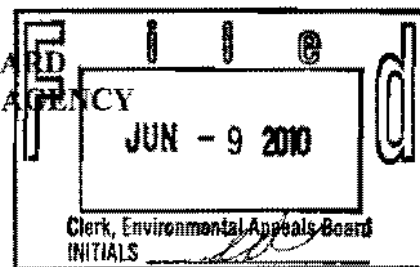

ORDER GRANTING MOTION FOR EXTENSION OF TIME  
TO FILE CERTIFIED INDEX OF THE ADMINISTRATIVE RECORD  
AND RESPONSE

By motion filed June 8, 2010, the Illinois Environmental Protection Agency ("IEPA") seeks an extension of time to file its response and a certified index of the administrative record in the above-captioned matter. Currently, the deadline for the filing of these documents is June 12, 2010. IEPA requests these items be due no earlier than July 19, 2010. IEPA states that it needs additional time because the permitting agency is still compiling the administrative record, which, after completion, must be reviewed by the Office of the Illinois Attorney General. Motion at 1. IEPA further indicates that it needs additional time because of the technical issues raised by the petition. *Id.* IEPA also states that it has discussed its request with the petitioner, Sierra Club, and the permittee, Vulcan Construction Materials, LP, and that they have no objections to the extension. *Id.* at 1-2.

Accordingly, for good cause shown, IEPA's motion for extension of time to file its response and the certified index of the administrative record is hereby **GRANTED**. IEPA must file these documents on or before **Monday, July 19, 2010**.
