ORDER REGARDING ATTACHMENT TO REGION 3 RESPONSE BRIEF

The U.S. Environmental Protection Agency, Region 3 ("Region") filed a response (with attachments) to the petition for review filed by the Borough of Plum in this matter. The first attachment to the Region's response (Tab A) is the Region's "Certified Index of the Administrative Record" ("Certified Index"). Item 12 in the Certified Index is entitled "Region 3 Framework for Evaluating Seismic Potential Associated with UIC Class II Permit" ("Region 3 Framework"). The Region's Response to Comments in this matter cites to a document entitled "Region 3 framework for evaluating seismic potential associated with UIC Class II permits, *updated September*, 2013." Region 3, Response to Comments for the Issuance of an Underground Injection Control (UIC) Permit for Penneco Environmental Solutions, LLC, at 6 (A.R. 32) (emphasis added). Attached to the Region's response as Tab K, however, is a document entitled "Region 3 framework for evaluating seismic potential associated with UIC Class II permits" and dated June 13, 2013.

Given the discrepancy in the dates for the Region 3 Framework cited in the Response to Comments and Region 3 Framework attached as Tab K to the Region's response in this matter, the Environmental Appeals Board directs that the Region file, on or before **August 24, 2018**, a copy of the version of the Region 3 Framework cited in the Response to Comments.
