

ORDER DENYING MOTION TO QUASH

Before the Board is Mr. Leonardo Ramos-Hernandez' Motion to Quash two orders issued by the Environmental Appeals Board on April 11, 2014,¹ in the above-captioned matter: the Board's Order Denying Extension of Time to File for Reconsideration and an Order Denying Intervention (collectively, "April 11th Orders"). This is Mr. Ramos' *third* attempt to challenge the April 10th Orders. The record of Mr. Ramos' motions and the Board's responses to those motions is available on the docket for this matter and will not be repeated here. In the Board's most recent order, the Board specifically stated that "Mr. Ramos has no further remedies under the Board's rules governing permit appeals" and that "[a]ny further pleadings or requests for reconsideration in this matter will be summarily denied." Order Denying Motion for Recusal of Panel and Denying Referral to Administrator for Rehearing at 6 (EAB May 30, 2014).

¹ In his motion, Mr. Ramos erroneously indicated these orders were issued on April 10, 2014.

Mr. Ramos' latest motion is equally without merit and, accordingly, is summarily denied. Additionally, to the extent that Mr. Ramos believes the administrative rules authorize or require him to file repeat or ongoing motions for reconsideration, he is mistaken.² This matter is closed. In the interest of administrative efficiency and the judicious use of government resources, the Clerk of the Board is instructed to reject any further motions on this matter. *See* 40 C.F.R. § 124.19(n).

² Mr. Ramos also filed a Motion for Leave to File via Email, in which he argues that the Board's eFiling system is flawed because it is not designed to allow the "filing of repeat Motions for Reconsideration of Clarification," which Mr. Ramos asserts is "a jurisdictional threshold for preservation of issues for Judicial Review." The Board accepts Mr. Ramos' Motion to Quash as filed, but denies Mr. Ramos' Motion to File via Email any future motions in this matter.
