ORDER GRANTING MOTION FOR A FURTHER STAY OF PROCEEDINGS AND DIRECTING STATUS REPORT

On March 13, 2018, the Environmental Appeals Board ("Board") issued an order continuing the stay of proceedings in this case until March 22, 2018, to provide EPA with time to determine whether to withdraw or withhold its consent to the parties' contingent settlement agreement. The Board's order directed the parties to file a status report by March 22, 2018, informing the Board of the progress EPA had made, and of any proceedings that may be necessary beyond March 22nd.

On March 22, 2018, the parties filed a joint status report requesting a further stay of the proceedings to March 29, 2018. The parties represent that while a final decision on whether to withdraw or withhold EPA's consent to the parties' contingent settlement agreement has not yet been made, EPA "expect[s] that a decision will be made shortly" and the parties "do not believe it is necessary to schedule further proceedings at this time."

Based on the parties' representations, the Board concludes that this case should continue to be stayed until March 29, 2018. The parties shall file a status report by March 29, 2018,

informing the Board of the progress EPA has made and of any further proceedings that may be necessary, beyond March 29th, to address this Petition.
