

ORDER EXTENDING STAY

By joint motion filed on October 26, 2004, U.S. EPA Region I (the "Region") and the City of Newburyport, Massachusetts (the "City") seek to extend the stay of proceedings in the above-captioned matter as well as an additional extension of time for the Region to file a response to the City's Petition for Review. Second Joint Motion for Stay of Proceedings and an Extension of the Response Date ("Second Joint Motion"). According to the Second Joint Motion:

The parties have met and made considerable progress toward a resolution of Newburyport's June 3, 2004 Petition for Review. In order to have sufficient time to conclude negotiations, the Region and Newburyport request that the Board stay the proceedings and extend the date for the Region to file a response in this case * * *.

For good cause shown, the Second Joint Motion is granted. The stay in this matter, as well as the deadline for the Region to file its response to the City's petition is extended until January 14, 2004.
