ORDER SCHEDULING ORAL ARGUMENT

Upon review of the record and the parties' submissions in the above-captioned matter, the Environmental Appeals Board has determined that oral argument may be of assistance in the Board's deliberations on this matter. Accordingly, the Board will hold oral argument on Thursday, September 19, 2024, beginning at 1:30 p.m. Eastern Time. Oral argument will be held in the Administrative Courtroom, U.S. Environmental Protection Agency, William Jefferson Clinton East Building, Room 1152, 1201 Constitution Avenue, NW, Washington, D.C. 20004. Counsel or other duly authorized representatives of the parties may request to present argument by videoconference.

The parties should plan to focus their oral arguments on the issue of whether U.S. EPA Region 5 clearly erred in determining the time period for the post-injection site care (PISC) plan. The Board has allocated 40 minutes total for this oral argument, divided as follows and in the following order:


- Twenty (20) minutes for Petitioners (Petitioners may reserve up to five (5) minutes of their time for rebuttal.)
Fifteen (15) minutes for Region 5
Five (5) minutes for Wabash Carbon Services, LLC

The Board directs each party to file a “Notice of Participation” by **Monday, July 29, 2024**, providing the name and contact information of the individual who will present argument on its behalf and indicating whether that individual will appear in person or request to appear via videoconference. If a party requests to participate via videoconference, the Clerk of the Board will contact the party to determine whether its videoconference equipment is compatible with the Board’s system.¹
