Hi Fred:

I called and left you a message about this the other day but wanted to follow-up with an email. Region 10 will be filing a motion for extension for filing the response brief. The Petition came in on July 26<sup>th</sup> and I was out on annual leave the week of August 5<sup>th</sup>. The OGC staff attorney (Jim Curtin) who is assigned to this appeal is currently out on vacation until August 26<sup>th</sup>. The filing deadline for the brief is August 26<sup>th</sup> and I will be out on annual leave from August 26<sup>th</sup>-Sept. 4<sup>th</sup>.
