1 **Ellen Kenwood:**

2 Hi. My name is Ellen Kenwood. And I live at 40
3 Old Stockbridge Road in Lenox, Massachusetts 01240.
4 And my message to General Electric and the EPA is
5 that I am outraged that they want to build a toxic
6 PCB dump in Lenox Dale which is the next town over
7 from where I live. It's enough that General Electric
8 has polluted the Housatonic River, and we can't swim
9 in it and we can't eat the fish that's in it. Now
10 they want to get rid of the PCBs that they put into
11 that river by building a dump right in the middle of
12 the beautiful Berkshire Mountains of Massachusetts
13 near Tanglewood and Jacob's Pillow. And millions of
14 people come here a year because it's so beautiful.
15 And now they want to make it toxic. Unbelievable.
16 I'm outraged at this. And also that when they --
17 when General Electric and the EPA decided to do this
18 they didn't consider the townspeople. They didn't
19 ask us our opinions. So they're getting our opinions
20 now after the fact. So anyway, General Electric and
21 the EPA have to come up with a better idea of how to
22 get rid of those PCBs from the Housatonic River.
23 This is not acceptable. Thank you. And have a

1 in a dump. The EPA's purpose is to protect the
2 environment. I feel like this would actually hurt or
3 pollute our environment, and it's not an acceptable
4 solution to the problem caused by GE over many years
5 in this area. I would like to request that the EPA
6 and the local government reevaluate this plan, and
7 not pursue it, and to figure out a way to properly
8 clean up this environment so that we can reverse the
9 damage that's been done so far and not cause more
10 damage to our environment and our residents moving
11 forward. Thank you for putting this on record. And
12 I hope that this is resolved in a way that can serve

17 Hi. My name is Sam Miller. I live at 111
18 Tamarack Ave. in Lee, Mass. Phone number is 413 243-
19 2749. I am opposed to what GE is doing in terms that
20 it is GE that created the situation in the first
21 place. And they were warned back in the latter '30s,
22 1930's, by a company producing the PCBs in Georgia to
23 expect litigation. GE has always, always, always
24 taken the least expensive way out of everything in
25 terms of maximizing profits. They never installed

1 | any kind of safety devices at the GE plant in
2 | Pittsfield until somebody was killed or seriously
3 | injured, then within a matter of moments there were
4 | safety devices installed, okay? The workers that
5 | were working around the transformers and what have
6 | you, they have died off from cancer now working with
7 | the PCBs. They were never given any kind of mob
8 | gear, or any kind of protective gear or what have you
9 | because that would be to recognize the inherent
10 | danger of working around PCBs. GE has run itself in
11 | such a manner as to be detrimental to the overall
12 | health of this country because it's always about
13 | profits, profits, profits. And bear in mind there
14 | was a Congressional hearing years back which what
15 | came to light was that no upper management people got
16 | to that position unless they were willing to do
17 | anything to maximize profits. So GE should not be
18 | permitted to take the sleazy way out in terms of
19 | rectifying the problem that they dam sure created
20 | themselves, and knowingly created. So thank you very
21 | much for your time.
