Thank you for your email, Valois. I have not yet received any official response to the OST from BLM regarding BLM's role in consultation. Hopefully, we receive that response soon.

We have had an internal follow-up meeting to discuss your presentation, and to prepare for BLM's participation. Also, I have been in contact with the Tribe's technical team by email but will need to talk with them about arranging technical meetings with EPA and BLM staff. Based on the list of issues in the proposed June 2020 meeting agenda and letters, completing all of the necessary technical discussion by October 2 may not be realistic, but the Tribe will work to move things forward in a sensible manner. I will also contact the Great Plains Tribal Water Alliance to see about their schedule. We should have a better idea of a time frame for technical meetings by middle of next week, assuming we get the BLM letter in the next few days.

We appreciate your efforts to work with the Tribe's consultation process, which is described in OST Ordinance 11-10, as the Tribe's technical staff is bound by that ordinance.
