RE: Notification of Clean Air Act (CAA) Tribal Title V Operating Permit Renewal for the Harvest Four Corners, L.L.C. (Harvest) – Los Mestenos Compressor Station, located on the Jicarilla Apache Nation Reservation; Permit No. **R6FOP-NM-04-R3-2023**.

Dear Mr. Jones:

The Environmental Protection Agency (EPA) wishes to inform you of our final permit decision to renew the Harvest Los Mestenos Compressor Station Part 71 operating permit. The facility operates under an existing title V permit that must be renewed every five years in accordance with the title V operating permit regulations at 40 CFR Part 71.

On October 26, 2023, EPA proposed for public comment the draft title V operating permit renewal for Harvest Los Mestenos Compressor Station located on Jicarilla Apache Nation Reservation. The public comment period for this permit action ended on November 27, 2023. After consideration of the pertinent Federal statutes and regulations and additional materials relevant to the application contained in the Administrative Permit Record, the EPA is issuing the final title V operating permit for the Los Mestenos Compressor Station.

During the 30-day public comment period on the draft permit, we did not receive a request for a public hearing but did receive one comment letter with multiple comments from Harvest. Therefore, EPA completed a response to comments (RTC) document and has incorporated non-substantive revisions to the permit based upon public comments. The final title V renewal permit, basis of decision for issuance of the permit, and the RTC document and other information relevant to EPA's decision regarding the Harvest Los Mestenos Compressor Station title V renewal permit are available through the online docket at www.regulations.gov, docket identification number **EPA-R6-OAR-2023-0250**.

The public notice for the final permit will be posted electronically (e-noticed) on EPA's website at <https://www.epa.gov/publicnotices/notices-search/location/New%20Mexico>. Within 30-days of this decision, any person who filed public comments on the draft permit can petition the Environmental Appeals Board to review any conditions of the permit being appealed. However, please see 40 CFR §

71.11(l) for the specific requirements for the petition. The final permit will be effective after 30 days of permit issuance if there are no appeals to the Environmental Appeals Board.
