I was recently notified that EPA Region III plans to issue an UIC Class II-D permit to Penneco Environmental Solutions for disposal of fluids from commercial oil and gas operations in Plum Borough, Allegheny County, PA. My organization has worked with many residents in Plum Borough who are concerned about the risks of developing gas infrastructure in their community. If you were to permit the Class II Injection Well, your agency would only exacerbate the potential risks to the health and safety of local people. Analyzing the records of nearly Class II injection wells permitted by EPA, ProPublica found that: "More than 1,000 times in the three-year period examined, operators pumped waste into Class 2 wells at pressure levels they knew could fracture rock and lead to leaks. In at least 140 cases, companies injected waste illegally or without a permit. In several instances, records show, operators did not meet requirements to identify old or abandoned wells near injection sites until waste flooded back up to the surface, or found ways to cheat on tests meant to make sure wells aren't leaking." Further, John Apps - a leading geoscientist and injection expert who works with US Department of Energy's Lawrence Berkeley National Laboratory has stated that he believes that injection wells pose a high risk to water resources.

Southwestern Pennsylvania has been haunted by an industrial history that has left local residents suffering. Communities are still fighting to clean up after the negligence from nuclear, gas, and coal companies. These industries have left us with polluted water, polluted air, radiation, and more. We simply do not know what the side-effects of injection wells will be 50 to 100 years from now. In Pennsylvania, our constitution guarantees that the Commonwealth serve as a trustee of natural resources for current and future generations.
