Peter:

After our phone call, I realized that you may not know that in any motion you file with the EAB, they will want to know whether the opposing party concurs or objects to the motion. Technically, the only parties to this process currently are the Tribe and the EPA.

The EPA does not oppose the motion for stay. However, the caveat is that we think we should be a party to your discussions, particularly if the discussions will involve changes to the Permit or other action on the Permit. We would be in the best position to tell you whether changes to the Permit would be feasible.
